VILLAGE OF FLEISCHMANNNS will hold a PUBLIC HEARING on FEBRUARY 25, 2021 AT 5:00 PM via ZOOM for the purpose of hearing public comments on the VILLAGE OF FLEISCHMANNNS' application to the Community Development Block Grant (CDBG) program for the 2020 program year for a Community Planning grant for Water and Sewer Infrastructure Improvements. The CDBG program is administered by the New York State Office of Community Renewal (OCR), and will make available to eligible local governments approximately \$50,000 listed in current Notice of Funding Availability for the 2020 Program Year Community Planning which will benefit the residents of the Village of Fleischmanns of which is 67% Low Moderate Income

The hearing will provide further information about the CDBG program and will allow for citizen participation in the development of any proposed grant applications and/or to provide technical assistance to develop alternate proposals. Comments on the CDBG program or proposed planning project will be received at this time. The hearing is being conducted pursuant to Section 570.486, Subpart I of the CFR and in compliance with the requirements of the Housing and Community Development Act of 1974, as amended.

Because of the Novel Coronavirus (COVID-19) Emergency and State and Federal bans on large meetings or gatherings and pursuant to Governor Cuomo's Executive Order 220.1 issued on March 12, 2020 suspending the Open Meetings Law, the Village of Fleischmanns Board of Trustees PUBLIC HEARING scheduled for February 25, 2021 at 5:00 pm will be held electronically via Zoom webinar instead of a public meeting open for the public to attend in person. Members of the public may listen to, view the Fleischmanns Village PUBLIC HEARING and SPECIAL MEETING, and participate by requesting a link to the Zoom meeting. The meeting will be recorded and Minutes of the PUBLIC HEARING and SPECIAL MEETING will be transcribed and posted on the village website.

Immediately following the PUBLIC HEARING, a SPECIAL MEETING also via Zoom will be held to consider Resolutions 002-2021 A COMMUNITY DEVELOPMENT BLOCK PLANNING GRANT APPLICATION and Resolution 003-2021 5% Local Match.

The location of the PUBLIC HEARING via ZOOM is accessible to persons with disabilities. If special accommodations are needed for persons with disabilities, those with hearing impairments, or those in need of translation from English, those individuals should contact the Village Clerk at 845-254-5514, at least one week in advance of the hearing date to allow for necessary arrangements.
