VILLAGE OF FLEISCHMANN'S NOTICE OF ADOPTION OF RESOLUTION SUBJECT TO PERMISSIVE REFERENDUM NOTICE IS HEREBY GIVEN that the Board of Trustees of the Village of Fleischmanns, NY, at their meeting on March 9, 2020 adopted a resolution to withdraw up to a total of \$5,500 from the Fire Department Capital Equipment Reserve Fund to be used toward the purchase of twenty-six (26) Delaware County-Wide Emergency Response System pagers. The resolution authorizing such withdrawal is subject to permissive referendum. Petition to put the resolution to referendum must be filed in my office within thirty (30) days of the adoption of said resolution, and if no such valid petition is filed by that date, the withdrawal authorized in the resolution is valid and can be undertaken by the Village Treasurer. PLEASE TAKE NOTICE, PURSUANT TO SECTION 5-508 OF VILLAGE LAW, the Tentative Budget for the Village of Fleischmanns for the 2020-2021 fiscal year has been prepared and filed with the Village Clerk at the Village Office, 1017 Main Street, Fleischmanns, New York, where it may be inspected by any interested parties during regular business hours. Said tentative budget includes a maximum compensation for the Mayor of \$2,627 per year and for Trustees of \$1,366 per year. A summary of the tentative budget is as follows: GENERAL FUND \$488,415 WATER FUND \$125,350 SEWER FUND \$477,075. There is no Tax levy increase in the Tentative Budget.
